Good morning,

I would like to request that the Board approve an extension of the contract for service between the CoC and the Wisconsin Association for Homeless and Runaway Services (WAHRS). The contract was originally approved from January 1 - May 31, 2022. We have been working very closely with WAHRS staff, including support to the local coalitions, local CCP development and review, the development of the RFP, and the CoC CCP. As we wrap up this phase of work, we have created a lengthy phase 2 list of items that need to be worked on over the summer in order for the YHDP funded projects to start in October. We would greatly benefit from the administrative support and expertise that WAHRS staff can provide. These tasks are eligible for reimbursement through the YHDP planning grant. I respectfully request the Board approve an extension of the current contract until 9/30/22.

The current contract was for \$16,800 or 420 hours. This averages \$3360/month or 84 hours/month. The extension would include an additional \$13,440 or 336 hours. Carrie Poser
