## 3B. Project Description

### 1. Provide a description that addresses the entire scope of the proposed project.

HUD funding is needed to continue to provide permanent supportive housing in Fond du Lac, Winnebago & Green Lake counties for single, chronically homeless individuals. This is the only PSH project in the WinnebagoLand CoC. ADVOCAP utilizes the coordinated entry process to identify those individuals who have been homeless for the longest period of time, have a disability & have the greatest barriers to securing housing on their own. We follow the established order of priority set by WIBOSCOC. A Housing First model is followed so that no one is turned away because of a background of substance abuse, criminal background, mental health, etc. Participants will have a choice of where to live based on their need, taking into account proximity to services, transportation, family & other support systems. Most participants will come from one of the area homeless/warming/DV shelters, but outreach is also conducted to identify those who may be living in places not meant for habitation. Once housing has been secured, staff involve participants in developing a self-sufficiency plan & reviews progress on a weekly basis as to overcoming barriers & developing the capacity to sustain permanent housing, including rehousing if necessary. Participants are assisted with access to food, clothing, furnishings & other basic needs & to access needed resources to overcome barriers & achieve stability. As needed, they are connected with Forward Services for Food Share & FSET. The agency operates a separate employment & training program & is able to assist persons with resumes, applications, interview skills, job readiness skills & employment retention, as desired by the participant. Legal Action staff & volunteer attorneys are able to assist with applications for SSI/SSDI, as well as with other civil legal issues, such as child support orders, drivers license reinstatement, cleaning up credit history, etc. Counseling services for DV, sexual assault, mental health, AODA & physical health are coordinated through community programs, hospitals & clinics. Transportation issues are addressed, including public transportation, after-hours options & alternative ride-share options. Expected outcomes include connection to all mainstream resources, including healthcare; increased/maintained income; maintained stable housing. Coc money will be spent on leasing dollars, case management and administrative costs.




