3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The program will provide 7 units of permanent housing in Fond du Lac, Winnebago, & Green Lake Counties for single chronic homeless persons. This includes 4 scattered-site units & 3 units owned by ADVOCAP. HUD funding is necessary because this is the only PSH project in the Winnebagoland CoC for singles. We work directly with homeless, warming & DV shelters, & participate in a coordinated assessment process, utilizing the VI-SPDAT to assess for the most vulnerable population. Outreach will be conducted to identify those who may be living in places not meant for habitation, including use of PIT surveys. All participants will meet HUD eligibility requirements. No specific target populations are established other than being chronic homeless. The agency follows established standards for prioritization adopted by the WIBOSCOC & uses a Housing First model for the program. The agency has established positive relationships with area landlords through previous homeless programs & participates in landlord associations to encourage their participation. Staff will engage participants in a way that establishes positive relationships; invites but does not mandate integrated risk reduction measures, & designs multiple approaches as to achievable steps to decrease resistance & increase motivation. We will involve other agencies in the process such as mental health/AODA service providers. The agency recognizes that tenants may have a history of AODA, mental health, risky behaviors &/or criminal backgrounds & that a considerable amount of time may be required before a participant is ready to move into/sustain permanent housing on their own.
